#### **LANGUAGE**

The official language of the 11<sup>th</sup> Asian Criminological Society Conference will be **English language**. Non-English Lanuage, e.g. Chinese or Korean, is acceptable **ONLY upon prior notice and approval** by the Chairman of the Organizing Committee (gerryjcano@yahoo.com).

#### **GUIDE FOR ABSTRACT SUBMISSION:**

- ♣ All abstract must be submitted in English Language;
- Abstract shall contain not less than 300 words which would cover the major aspects of your research, including: 1) the purpose of the study and the research problem(s) you investigated; 2) the design of the study; 3) major findings of your analysis; and 4) a brief summary of your interpretations and conclusions;
- ♣ If the abstract is not on this format, it should contain enough information of the frame of the problem or the study, findings and analysis and the conclusions;
- ♣ If a NON-English abstract has been allowed by the committee, it shall conform to the contents of an acceptable abstract as mentioned above, together with the English Translation of the abstract;
- ♣ All abstract in English language or otherwise must use the Font Style Arial, Font Size 12, Paper Size 8.5 x 11 inches, following 1 inch or 2.54 cm margin in all sides:
- Submission and Acceptance of abstract DOES NOT automatically register you to the conference;
- ♣ Submit your abstract to <u>pcap.philippines@gmail</u> or to <u>gerryjcano@yahoo.com</u>;
- There shall be partial notice of acceptance of your paper which will be sent to you via email by the organizing committee;
- ♣ The Official Notice of Acceptance of your paper shall be given via email, only upon payment of the conference registration fee;
- ♣ All participants must PAY the registration fee either through the Bank or On-site;
- Only abstract/s of participants who have paid the registration fee before the cut-off date shall be included in the printed program;
- On-site conference registration is acceptable and allowed.

### The Session Chairperson

- Adjourn the session promptly at the announced time;
- If for some reason the presenter was not able to present, he/she can only be accommodate the last session of the conference, Provided, prior approval has been secured by the organizing committee.
